# **Akron Municipal Court Sealing Dismissal Packet**

\*It is your responsibility to review all documents in this packet and review the guidelines to determine if you can get your prior convictions or dismissals sealed.

# **Sealing Process for Akron Municipal Court**

- 1. Obtain the Akron Municipal Sealing Packet from the Clerk of Courts.
- 2. **Carefully read and review** the Sealing Municipal Cases Information Sheet to determine if your past cases qualify for sealing.
  - You CANNOT have any criminal or traffic proceedings pending against you in ANY COURT.
  - Convictions arising from the same incident count as one.
  - Akron Municipal Court can only seal cases that were handled in the Akron Municipal Court (**MISDEMEANORS ONLY**).
- 3. **Complete** the Application for Sealing of Dismissal.
- 4. **Complete** the Supplemental Sealing Information Form.
- 5. Complete the Affidavit for Sealing of Dismissal.
- 6. **Complete** the Order for Sealing of Dismissal.
- 7. **Complete** the Ohio Attorney General Form.
- 8. **Sign the bottom of this form** acknowledging that you have read and understand the process outlined herein.
- 9. **Submit payment** along with the Application, Supplemental Form, Affidavit, Order, Attorney General Form, and Sealing Process to the Akron Municipal Clerk of Courts.
- 10. The fees to process your sealing application are as follows:
  - The application fee is \$50.00.
  - An applicant can request to seal multiple cases on one application.
  - FEES are **NOT** refundable so please make sure you review the qualifications before you apply for sealing.
- 11. The entire process will take between 45 and 90 days. You will receive notice of your hearing date at the address provided in this packet.

# **Sealing Municipal Cases Information Sheet**

Information adapted from material produced by the Ohio Justice and Policy Center, the Legal Aid Society of Columbus, and Southeastern Ohio Legal Services

To apply for record sealing, the applicant can complete the appropriate sealing packet as provided by the Clerk of Courts office.

# Can I seal my case?

An applicant can seal a case if the case is eligible for sealing and there are no open or pending criminal cases, including warrants and traffic cases. The Ohio Revised Code (R.C.) provides the types of cases that can be sealed.

# What case is eligible?

Any dismissal can be sealed.

Most municipal convictions can be sealed, except for:

- The following traffic-type cases, unless R.C. 2953.61(B)(1) applies:
  - o R.C. 4506: Commercial Driver's Licensing offenses
  - R.C. 4507: Driver's License offenses
  - o R.C. 4510: Driver's License Suspension offenses
  - o R.C. 4511: Operation of Motor Vehicles offenses
  - o R.C. 4549: Motor Vehicle Crimes
- Sex offenses where the offender must register pursuant to R.C. 2950
- Offenses where the victim was under 13 (except non-support of dependents under R.C. 2919.21)
- Domestic Violence (R.C. 2919.25)
- Violations of a Protection Order (R.C. 2919.27)

There are exceptions and special cases, so if you are unsure if your case is eligible, please consult with a lawyer or contact a clinic such as the University of Akron Reentry Clinic

### When can I apply?

It depends on the level of offense. After there is a final entry and all sentencing/files/obligations are complete, the applicant must wait an additional amount of time based on the level of offense:

• Dismissal: No ad	lditional time
--------------------	----------------

- Minor Misdemeanor: 6 months
- Most Other Misdemeanors: 1 year
- Theft in Office (R.C. 2921.43): 7 years
