*It is your responsibility to review all documents in this packet and review the guidelines to determine if you can get your prior convictions or dismissals Expunged.

Expungement Process for Akron Municipal Court

1. Obtain the Akron Municipal Expungement Packet from the Clerk of Courts.
2. **Carefully read and review** the Expungement Municipal Cases Information Sheet to determine if your past cases qualify for Expungement.
 - You **CANNOT** have any criminal or traffic proceedings pending against you in **ANY COURT**.
 - Convictions arising from the same incident count as one.
 - Akron Municipal Court can only Expunge cases that were handled in the Akron Municipal Court (**MISDEMEANORS ONLY**).
3. **Complete** the Application for Expungement of Dismissal.
4. **Complete** the Supplemental Expungement Information Form.
5. **Complete** the Affidavit for Expungement of Dismissal.
6. **Complete** the Order for Expungement of Dismissal.
7. **Complete** the Ohio Attorney General Form.
8. **Sign the bottom of this form** acknowledging that you have read and understand the process outlined herein.
9. **Submit payment** along with the Application, Supplemental Form, Affidavit, Order, Attorney General Form, and Sealing Process to the Akron Municipal Clerk of Courts.
10. The fees to process your Expungement application are as follows:
 - The application fee is \$50.00.
 - An applicant can request to Expunge multiple cases on one application.
 - FEES are **NOT** refundable so please make sure you review the qualifications before you apply for sealing.
11. The entire process will take between 45 and 90 days. You will receive notice of your hearing date at the address provided in this packet.
